This required external peer review was conducted in accordance with the Council of the Inspectors General on Integrity and Efficiency (CIGIE) Inspection and Evaluation Committee guidance as contained in the CIGIE *Guide for Conducting Peer Reviews of Inspection and Evaluation Organizations of Federal Offices of Inspector General (Blue Book).* The peer review was conducted from October 26, 2022 through March 22, 2023.

The Special Inspector General for the Troubled Asset Relief Program assessed the extent to which AmeriCorps Office of Inspector General's (OIG) Office of Audit complied with the CIGIE Quality Standards for Inspection and Evaluation, December 2020 (Blue Book). This assessment included a review of AmeriCorps OIG's' internal evaluation policies and procedures implementing the Blue Book standards for the three-year period under review. It also included a review of selected inspection and evaluation reports issued between October 1, 2019 and September 30, 2022 to determine whether the reports complied with the Blue Book standards and AmeriCorps OIGs internal policies and procedures.

The Reviewing OIG determined that AmeriCorps OIG's policies and procedures generally were consistent with the seven Blue Book standards addressed in the external peer review. Each of the reports reviewed generally complied with the seven covered Blue Book standards.
